On the recommendation of the Odisha Public Service Commission, Cuttack, the following candidates are appointed as Veterinary Assistant Surgeon (VAS)/ Additional Veterinary Assistant Surgeon (AVAS) in Odisha Veterinary Service (Group-B) in the scale of Pay of ₹.9,300-34,800/- with Grade Pay of ₹.4,600/- and D.A. & other allowances as admissible from time to time by the Government and posted to the places as mentioned against the name of each of the candidates. They shall remain on a probation for a period of two years from the date of joining in the post. Their services are subject to the following terms and conditions as per Service Rules.

1. The appointments are purely temporary and terminable at any time without prior notice and without assigning any reason thereof.
2. The appointees should join at their places of posting within 30 (thirty) days with effect from the date of issue of this Notification failing which, their appointment shall be automatically cancelled.
3. The appointees shall produce his/ her Medical Fitness Certificate issued by a Medical Officer not below the rank of Assistant Surgeon.
4. The appointees shall produce Character Certificates issued by any two Gazetted Officers at the time of joining.
5. No TA/DA shall be allowed to join in the place of posting.
6. The period of probation shall count towards increment.
7. The appointee shall furnish a declaration at the time of his/ her joining in the post that there is no criminal antecedent/ case pending against him/ her. In case, it is detected subsequently that such criminal antecedent/ case is pending against him/ her, he/ she will be liable for termination from Government service.


