The Director, Animal husbandry and Veterinary Services, Odisha, Cuttack (herein after referred as “DIRECTOR”) invites Expression of Interest for Establishment of “**Chicken-Fresh**” outlets on PPP mode in various locations of Odisha for retail sale of poultry meat & poultry products.

The Director of Animal Husbandry & Veterinary Services, Odisha, Cuttack intends to establish “Chicken-Fresh” outlets in various locations of Odisha for retail sale of poultry meat & poultry products. The programme involves coordinated efforts for establishment of “Chicken-Fresh” outlets with Air-conditioning to cater to the poultry loving population of the State. The Animal Resources Development Department shall help in acquiring required land for setting up of Chicken-Fresh outlets from District Administration / General Administration Department / Departmental in different locations of the State.

Expression of Interest (Non-transferable) together with terms and conditions and information docket is obtainable from the office of the Director of Animal Husbandry & Veterinary Services, Odisha, Mangalabag, Cuttack-1 on payment of Rs. 1,060/- (Rupees One thousand Sixty only ) by cash ,which includes cost of EOI documents at Rs.1,000/- + VAT 6% i.e. Rs. 60/- .
