



Terms and conditions:

1. Vehicles should process commercial registration number. Fuel and lubricant will be supplied by Owner / Agency of the vehicle.
2. Payment shall be made on production of bills on each tour basis at the end of each month basing on the Kms. covered and halting charges or on daily basis for short tour.
3. The vehicles should be provided on any day including Sunday and holidays, as and when required in the schedule time on intimation over phone / written order.
4. The approved rate shall remain valid up to one year from issue of the acceptance order without any revision in it within the year.
5. A sum of Rs.5000/- shall be deposited by the intending bidders in shape of Account Payee Bank Draft drawn in favour of the **JOINT DIRECTOR, ANIMAL DISEASE RESEARCH INSTITUTE, PHULNAKHARA, CUTTACK** as security deposit along with the quotation, failing which his quotation will be rejected.


