He should have experience/ competent personnel having such technical knowledge in the field of preparing DPR on Good Manufacturing Practices (GMP) compatible Veterinary Biological Production Laboratories & allied facilities like Fire safety, Factory and Boiler, Pollution Control, Bio-medical waste management, drug license etc with proper Bio safety measures.
- 3) The consultant has to provide necessary technical advice during the execution of the work according to the approved DPR prepared by him till successful and final production of vaccines.
